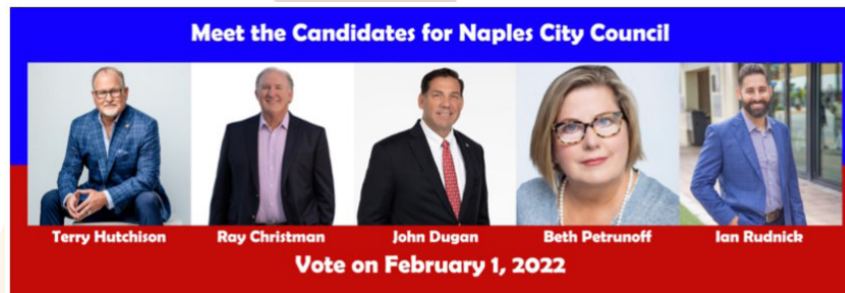

## Make Sure Your Voice is Heard

On February 1st, voters in Park Shore and other parts of the City will have the opportunity to elect three of the seven members of Naples City Council. This election will have a critical impact on our neighborhood, and our City for the next four years.

Election results are often determined by a very small number of votes. In the last City elections in 2020, turnout was low in Park Shore and we lost our two local representatives on City Council. So, it is very important that each of us vote.



### **There are several options to cast your vote:**

You have until January 22nd to request a Vote-By-Mail Ballot, which can be done by contacting the Collier County Supervisor of Elections through the website [www.colliervotes.com/voters/vote-by-mail](http://www.colliervotes.com/voters/vote-by-mail) or by phone at (239)252-8683.

In-person early voting will be held on January 26, 27, 28, and 29 from 10 a.m. to 6 p.m. daily at the Norris Center located at 755 8th Avenue South (next to Cambier Park and across the street from Naples City Hall).

On Election Day, February 1st, the polls will be open from 7 a.m. to 7 p.m.

Among the many critical issues in our neighborhood that will be decided by the three candidates elected on February 1 are: repairing the city-owned seawalls along Gulf Shore Boulevard North, cleaning the water in the stormwater storage lakes that flow into Venetian Bay/Moorings Bay, and regular beach renourishment to protect us from sea level rise and a hundred-year storm.

Do not be complacent, please vote. Park Shore needs your support!

## Help Protect Our Clean Waterways

The Park Shore Association is proud to be playing a leading role in the City of Naples' efforts to reduce the consequences created by nitrogen and phosphorous chemical fertilizers entering our waterways.

Under the direction of Board member Jo Ann Smallwood, the Association is participating in a pilot program at the Raymond Lutgert Park at Park Shore using an organic biological product, Quantum Growth, developed by Eco Labs. After three years, the park and other test sites across the city continue to grow in a health manner without the harmful discharges.

In a recent presentation to the City, Smallwood reported that Quantum Growth helps reduce the amount of pests and diseases. The plants have improved healthy color and appearance, they flower more, and the cost is less than chemical fertilizers.

With this success, many other landscape contractors have stopped using chemical fertilizers and are now maintaining sod and plantings with Quantum Growth. Further updates will be provided.

The Park Shore Association is proud to set an example as leaders and stewards in protecting the environment, protecting us humans and doing the right thing that makes sense!

### Reminder: New Leaf Blower Ban Now in Effect

In October 2020, the City of Naples amended its Noise Ordinance to prohibit the use of gasoline-powered leaf blowers throughout the City. This prohibition officially took effect on October 21, 2021.

Battery and electric leaf blowers will continue to be allowed as long as they do not generate a decibel level above 65 dBA. All battery and electric leaf blowers must have a manufacturer's label indicating they meet the noise level requirements.
